Sir/Madam,

The SAS/RA/I/CPD Examination is normally held twice in a year — Supplementary Examination in the 1st quarter and Main Examination in the 3rd quarter of the financial year. However, in view of the situation arising due to outbreak of COVID-19 pandemic, the Supplementary Examination (corresponding to Main Examination 2019) could not be held till date. It has, therefore, been decided to complete the registration process and be prepared for conducting the examination at a short notice as soon as the situation is conducive.

- 2. The registration portal will GoLive from 26 August 2020 to enable registration of eligible candidates who intend to appear in the upcoming examination. Only pre-registration of existing candidates (i.e. those who had registered for SAS/RA/I/CPD Examination during 2000 to 2019) will be done in this place. Necessary guidelines in this regard is enclosed (Annexure I & II).
- 3. Head of the Department (HoD) of the office where registration for examination will be done may nominate an officer, not below the rank of Ty. Accountant General, as Examination Registration Officer (ERO), who will manage the registration process of candidates. The ERO will be required to verify and validate the data entered in the online registration forms.
