
**Subject: In-house test in respect of eLearning module on 'Introduction to IT Audit'.**

All officers, who have not cleared the test earlier, are required to fill up the attached proforma and submit it to this section latest by 13.01.2020 .


**Candidates are requested to take note of the following: -**
